BBSRC-NSF/SBE Application Guidance

This is a guidance document created to assist applicants to the BBSRC NSF-SBE scheme in the completion of their application. It is specific to the scheme and should be used in conjunction with the opportunity specific guidance and the following information:

Full Application Stage

Please note, this scheme requires submission of an expression of interest before applications are invited to full stage submission. The guidance here is only applicable if a full application is invited following an expression of interest. Applications submitted to BBSRC Lead agency that have not been invited to submit a full application will be rejected.

- Full applications (both the UK and US components) will undergo a single peer review process lead by either BBSRC or NSF/SBE, depending on where the application is submitted.
- Applications will be reviewed in competition with other unsolicited applications
 or with applications received in response to a specific opportunity by the lead
 funding agency. That is, applications submitted to the lead agency management
 plan agreement will not undergo a special review process.
- Applications will be peer reviewed in accordance with the lead agency's criteria.
 While not identical, NSF and BBSRC ask reviewers to evaluate the proposed project on both its scientific and/or intellectual merit.

Full submission process to BBSRC – UK-led applications only

- All BBSRC Lead Agency applications will be assessed through 'BBSRC standard research grant: applicant-led mode' opportunities. Please check the <u>UKRI-BBSRC</u> website for the most up to date opportunity information including any associated deadlines.
- Each application will be assessed by one of the <u>research committees (A-D)</u> in the manner detailed on the opportunity and, in competition with all other applications submitted to the same opportunity.
- Full applications must be submitted within one year following an invitation from the expression of interest.
- You are reminded that the UK component of projects submitted to this lead agency agreement through the BBSRC responsive mode must not exceed £1M, and that the BBSRC awards 80% of full economic costs. Additional guidance can be found on <u>our</u> <u>website</u>.
- We allow for a +/- 10% change in budget between the expression of interest and full stage application submission. If there is a larger change in budget, please contact NSF (<u>sbe-ukri@nsf.gov</u>) and BBSRC (<u>bbsrc.iru@bbsrc.ukri.org</u>) to explore whether this is possible.
- Applications should include all the documentation expected for a standard research grant: applicant-led mode application, as well as an additional document relating to the NSF budget. Please use the template found here.

Studentships or student resource may not be requested, or included, on BBSRC research grant applications so please ensure the UK side does not include doctoral students.

Frequently Asked Questions

Eligibility

Q. What are the eligibility criteria for UK partners?

UK applicants must be eligible for BBSRC standard research grant: applicant-led funding. Further information about eligibility criteria can be found <u>online</u>. Queries concerning eligibility of the UK partner should be sent to <u>eligibility@bbsrc.ukri.org</u> with <u>SBELeadAgency@ukri.org</u> cc'd.

BBSRC is unable to provide guidance on the eligibility of US partners.

Q. What are the eligibility criteria for US partners?

US applicants must be eligible for NSF funding. Queries should be sent to sbe-ukri@nsf.gov.

Q. Are applicants based in other countries eligible to apply?

No, only UK and US based applicants are eligible.

Funding

Q. Will BBSRC pay costs incurred by the US partners?

No, funding for activities undertaken by US partners will be met solely by the NSF. Likewise, NSF will not fund costs incurred by the UK partners; these will be met by BBSRC.

Q. At full stage, should costs for the US component of the project be included in the BBSRC responsive mode application?

A copy of the proposed, justified NSF budget request from the US members of the collaboration must be filled in using the NSF budget form template. This must be uploaded to the application in TFS as a PDF under the 'BBSRC scheme' section.

Costs being requested from NSF for US based investigators must not be entered in the TFS fields for UKRI fEC.

Costs for the UK component of the project must be requested from BBSRC by completing the relevant finance fields of the TFS application as normal.

Remit

Q. Is my application within remit for this scheme?

Projects must be within BBSRC and NSF/SBE remits. Further information about BBSRC remit can be found <u>online</u>. Queries concerning BBSRC remit should be sent to <u>remit@bbsrc.ukri.org</u>

BBSRC is unable to provide guidance on NSF/SBE remit, please contact sbe-ukri@nsf.gov

Q: Which BBSRC Research Committee should I apply to?

Applications should be submitted to the committee you feel would be best placed to assess your application (A-D). Following submission, BBSRC will check your choice in line with the remit of the committee and make a final decision as to which committee will assess your application.

Q. Will applications submitted to BBSRC be reviewed by the usual research Committees or will a separate panel be used?

When BBSRC is the lead agency, all applications submitted will be assessed by the four committees (A-D) in the usual manner and in competition with all other applications submitted to the opportunity. Applicants should indicate which research committee is likely to be best able to assess the work proposed in the BBSRC schemes section.

Other

Q: Where do I submit my Full Stage application?

All BBSRC Lead Agency applications will be assessed through 'BBSRC standard research grant: applicant-led mode' opportunities. All information and documentation should be submitted to BBSRC through UKRI's TFS. Applications received via UKRI's TFS will be managed following BBSRC internal processes.

Q. What if I have difficulty meeting the stated deadlines, or submitting the full application within one year of receiving the EOI acceptance?

Please avoid problems surrounding opportunity deadlines by submitting early. BBSRC recommends that you submit to your university's research office well before any stated opportunity deadline to allow sufficient time for them to submit the application. We are unable to accept applications that are submitted after the opportunity stated deadline.

If more time is needed for full application preparation above the provided one year, an additional EOI may be required.

Q. Do applications under the BBSRC-NSF lead agency scheme receive any uplift during the assessment process or would the applications qualify for other applicant-led mode schemes, e.g. New Investigator, IPA, LINK?

No, applications will be assessed in competition with all other applications and will receive no additional uplift. Schemes such as New Investigator, IPA and LINK are not applicable to applications submitted to the BBSRC-NSF lead agency scheme. Please **do not** submit the full application to the BBSRC New investigator award: applicant-led mode opportunities.

Q. Will BBSRC share information I submit to the call with NSF?

Yes. As outlined in the call text and lead agency management plan, for the purposes of managing the administration of the lead agency scheme full stage applications will be shared between BBSRC and NSF staff.

Q. What happens if my application is recommended for funding?

If successful, applicants will need to submit a copy of their application to the non-lead agency before funding can be awarded. No further peer review will be undertaken.

Q. If funded, will the UK and US components need to have identical start dates?

No, NSF and BBSRC do not require identical start dates for the UK and US components. However, we would expect the UK and US component to have aligned timeframes to enable a true partnership to take place.
