

# Background and call development

ESRC currently commits around a third of its annual World Class Labs capital budget to data services (~£12M) such as the UK Data Service, CLOSER and the Census Longitudinal Study Research Support Units and DigitalFootprints. Many other investments also provide support to data users. The majority of our grants for these investments will end in September 2024. The Future Data Services strategic review will enable ESRC to decide how best to invest in data services beyond 2024. It is focusing on user requirements in five key areas:

- Data Discovery (including curation, long-term preservation, metadata systems management, searchability, data linkage);
- Data Access and User Support (including training and capacity building), technology (including requirements for Trusted Research Environments;
- **Technology** (including high performance computing, software delivery, Trusted Research Environments)
- People, Culture and Places: (technicians: career management to support capacity building in data services infrastructure)
- Ethics, Legal, Public Engagement, establishing value-for-money







# **Objectives**

- Provide senior-level strategic advice and technical expertise to support the programme.
- Lead the development and critically appraise a series of data service options to meet requirements of our research and data owner communities for the rest of the decade.
- Provide leadership for the development of bids for enhanced funding for future infrastructures
- Support development of the business case for ESRC's next phase of investment in data services.
- Provide scientific leadership and strategic direction regarding the commissioning, coordination, and optimising the potential impact of future data service investments.
- Act as a public champion for ESRC's ambitions for the data service landscape.



# **Essential requirements**

- Thorough understanding of the data services landscape, within the UK and internationally, through an interest in data sciences or traditional social science disciplines.
- Vision and the ability to understand the big picture and broader strategic concerns, and map how various landscape components can fit together.
- Understanding of the sensitivities around the use of data for research and the different approaches for managing these.
- An excellent track record of building effective relationships at all but especially senior levels between academia, government, industry and/or the third sector and the public.

## Desirables

- Understanding of the importance of acquiring and curating data; providing data access; understanding of legal frameworks that support access to data; issues around confidentiality and ethical use of data; data management frameworks (such as the Open Archival Information System, OAIS)
- •Relevant experience in shaping and successfully leading an applied quantitative and/or qualitative data-based research programme or related research endeavours
- •Proven experience with working with a wide range of data providers/data owners across government and industry/third-sector and a proven ability to tailor communications appropriately for different audiences



# Management and governance

Working with the ESRC office and Head of Data Services, agreeing a timetable for activities and outputs to be delivered, including for example:

- •A plan for activities to support coordination and collaboration to support Future Data Services programme.
- •Development and implementation of a stakeholder engagement plan to gather evidence.
- •A plan for development and delivery of the scientific case as part of a wider business case.
- •Regular oversight and sharing with the ESRC Chief Executive Office, Programme Board and Expert Groups.

- Assessment panel meeting March 2022
- Interviews of shortlisted applicants April 2022
- Grant start date May/June 2022

# **Applicant eligibility**

#### **Organisation eligibility**

- Applications can be submitted by UK higher education institutions (HEIs) and some UK independent research organisations (IROs) and public sector research establishments (PSREs)
- A full list of IROs and PSREs that are eligible for funding is available on the UKRI website

#### **Applicant eligibility**

- The Principal Investigator (PI) must be based at/or hosted by a UK HEI or eligible UK IRO or PSRE
- The PI should be based at the organisation submitting the application.



# Proposal content guidance

The following are mandatory attachments:

- Case for Support (maximum of 6 sides of A4)
- Justification of resources (maximum of 2 sides of A4)
- CVs (for the named applicant, including publication record) (maximum of 2 sides of A4)
- Institutional Letter of Support (from the lead organisation) (maximum of 2 side of A4)
