



# Roadmap for the open access research information landscape: key project activities

#### Updated May 2023

The <u>UKRI Open Access Policy</u> outlines technical requirements for research articles. Publishing and repository systems need to support the requirements so the necessary requirements for access and curation are applied to the research articles in scope of the policy.

As outlined at <u>implementing our open access policy</u>, UKRI commissioned <u>MoreBrains Cooperative</u> to undertake an analysis to inform how far these requirements are currently adopted. This has helped to identify actions that are necessary to improve the metadata landscape and to fully enable the requirements to be implemented. The final report of this analysis is available at <u>roadmap for the open access research</u> <u>information landscape</u>.

UKRI is now taking forward work to support implementation and we are working with MoreBrains Cooperative over 2023 to support necessary developments. MoreBrains will work with UKRI to:

- · consult the repository and publishing communities on their current state of readiness to meet policy requirements
- develop best practice and technical guidance to coordinate with relevant community initiatives to improve support for specific components of the policy
- identify ongoing programmes of support needed to extend the coverage and capabilities of the platforms and schemas in use to meet policy requirements.

**Table one** in this document sets out at a high level the activities the project will encompass. Ongoing activities will be required in 2024 and beyond, and these will be specified as more is learned and consensus is built during this project.

**Table two** sets out in more detail which policy requirements will be focused on at which stage, and which community or initiative will be consulted or prioritised for action.



### MOREBRAINS

During May-July 2023 there will be community engagement on readiness and options. **Table 3** sets out our proposals for which community or initiative will be engaged with respect to each policy requirement as part of this activity.
