**Remit**

The majority of the UK's part of the proposal must be within ESRC's and/or AHRC's remit. The ESRC, as the UK's largest funder of economic, social, behavioural, and human data science, supports independent, high-quality research which has an impact on business, the public sector and the third sector. The Arts and Humanities Research Council (AHRC) supports world-class research in a wide range of subjects from history and archaeology to philosophy and languages. AHRC also fund more contemporary research- for example, on the design and effectiveness of digital content and the impact of artificial intelligence. Please ensure you identify in your **Notice of Intent to Apply Form which UKRI Research Council (AHRC or ESRC) you are applying to.**

**Who can apply?**

Proposals may only be submitted by Research Organisations who are eligible to apply to UKRI. This includes:

- Higher Education Institutions (HEI) that are directly funded or research by Education Funding Councils (HEFCs) in England (Research England), Scotland (SHEFC) and Wales (HEFCW), and Northern Ireland (DFE)
- Independent Research Organisations that have received recognition to apply to the Research Councils, and Research Council Institutes.

Standard AHRC and ESRC contractual eligibility guidelines apply for this call. Prospective applicants must be employed by the Research Organisation (RO) submitting the proposal. Applicants who are not established members of a recognised RO must be accommodated by the RO and provided with appropriate facilities to carry out the research. These requirements also apply to all individuals named as co-applicants. For such applicants, the RO must provide a covering statement confirming that, in the event of a grant, it will provide accommodation and facilities for the applicant such as would be provided for established members of staff. ### **International Co-Investigators**

Researchers who are not based in T-AP member countries may participate in the project as Co-Investigators or Project Partners, where there is a clear rationale for doing so. Please note that any academic researcher from an established international research organisation (outside of the participating T-AP countries' applicants) of comparable standing to a UKRI-eligible UK High Education Institution will be eligible to be listed as an international co-investigator under this call. ### **Connection between the DGT call and UK policy makers**

UK-based applicants are required to plan to engage with the [Strategic Coordination Hub for Local Policy Innovation Partnerships \(LPIP\)](#) which has been established to serve as a gateway to a UK policy audience. The connection with the LPIP is aiming to strengthen partnerships and collaborations between researchers, policymakers (local, regional, national) and other relevant local stakeholders. Please include a brief description of the type of activities you're planning to deliver with the LPIPs hub.

### **Available amount of funding**

UKRI is making a total of **£5 Mio** available for the DGT call. The minimum UK funding per awarded project is £ 300,000 and the maximum UK funding per awarded project is £ 400,000 at 100% Full Economic Costs (fEC). Please note in accordance with UKRI's standard funding model, we will fund 80% of the fEC of eligible costs for the UK team participating in successful proposals to this call (apart from those items which are eligible to be funded at the exceptional rate of 100%). The UKRI budget requested in your proposal should represent the exact funds being requested from UKRI. You are required to enter 100% and 80% values in the UKRI budget form.

### **Eligible costs for UK researchers**

The UK team requesting funding from UKRI must prepare a budget detailing costs and the requested amount in an UKRI budget template and submit as an attachment of your proposal. The budget template for submitting costs can be found on the [call website](#). Applicants are encouraged to consult the [ESRC Research Funding Guide](#) and [AHRC Funding Guide](#) for information about eligible costs that can be requested for UK applicants. Please note that no grant associated doctoral studentships linked to a UK team will be funded under this call.

### **Miscellaneous**

All applicants must be able to meet the time commitment to the project as stated in the proposal. Proposals which may result in over-commitment of time, for any applicant across all of their UKRI projects, will not be approved. ESRC does not allow the resubmission of any previously unsuccessful proposal. ### **Post-Award Information**

Successful projects will be invited to submit their application to the UKRI Funding Service. This is a formality, and any such projects will not be subject to further assessment. The submission route will be confirmed when the project decision is conveyed to you.

The grant holder is asked to report the outputs, outcomes, and impact of their funding through UKRI's nominated outcomes collection system. This is currently the researchfish system provided by Interfolio UK. UKRI-funded researchers are expected to comply with the UKRI open access policy (<https://www.ukri.org/funding/information-for-award-holders/open-access/>) on research publications and outputs.
