

# KTP Scoring criteria

There are four scoring criteria for KTP applications

- Impact, Innovation, Challenge & Cohesiveness
  - Scored 1 (lowest) to 10 (highest) to create a total score out of 40

# Impact

- 9-10 The application demonstrates well defined substantial and realistic positive impact on the organisations/company's financial position (i.e. profit, turn-over, productivity and cost savings) compared to current trading and embeds significant new capabilities within the company or across the organisation as a whole. The project will develop a culture of and capacity for ongoing innovation and have other wider impact (economic and/or societal) beyond the partnership.
- 7-8 The application demonstrates well defined and realistic positive impact on the organisations/company's financial position (i.e. profit, turn-over productivity and cost savings) and embeds new capabilities within the company which will develop a culture of, and capacity for, ongoing innovation. There is potential for impact (economic or societal) beyond the partnership.
- 5-6 The application has realistic and defined impact on the organisations/company's financial position and embeds realistic and defined new capabilities within the company or across the organisation as a whole
- 3-4 The application has unrealistic or ill-defined impact on the organisations/company's financial position or fails to embed new capabilities within the company or across the organisation as a whole
- 1-2 The application fails to demonstrates realistic or feasible impact on the organisations/company's financial position and does not embed new capabilities within the company or across the organisation as a whole

# Challenge

- 9-10 The application clearly demonstrates that the project challenges the practices of the company partner and the market(s) it operates in. The application will clearly demonstrate that the academic team will be stretched in their translational thinking to deliver the project. The application will demonstrate that the Associate will be at the centre of managing and delivering such a project and will get excellent technical and commercial exposure.
- 7-8 The application demonstrates a realistic and well-defined challenge for the company such that the company's practices or processes will change. The application demonstrates that the academic team need to deliver creative solutions and that the Associate will be stretched in technical and commercial terms.
- 5-6 The application demonstrates a realistic and well-defined challenge for company but it will not lead to significant change of practice within the company. The application demonstrates that the academic team need to deliver solutions based on current knowledge, without being cutting edge solutions, and that the Associate will be expected to show above average technical and commercial skills.
- 3-4 The application has unrealistic, ill-defined or low level of challenge for any of the academic team, the Associate, or the organisation/company
- 1-2 The application FAILS to demonstrate a defined or realistic challenge for any of the academic team, the Associate or for the team within the organisation/company
