Regional Innovation Fund (RIF) grant allocations for financial year 2023 to 2024

Dear Vice-Chancellor or Principal

Notice of funding

- 1. Research England has received additional funding from the Department for Science, Innovation and Technology (DSIT) for financial year 2023 to 2024. This is in addition to funding previously issued¹, and is allocated as the Regional Innovation Fund (RIF) of £48.8 million.
- 2. <u>DSIT's priorities for RIF</u> are to particularly target high performing universities in areas with lower levels of investment in research and development (R&D) as well as with high performance in regeneration funding, and support universities particularly to focus on business engagement and leading to economic growth.
- All Higher Education Providers (HEPs) in receipt of a Higher Education Innovation
 Funding (HEIF) allocation for 2023 to 2024 will receive a RIF allocation. It is important to
 note though that RIF has a different focus to HEIF set out in DSIT priorities, with a
 different allocation method.
- 4. RIF is allocated by applying a regional weighting to HEPs' 2023 to 2024 main HEIF allocations (excluding HEIF top-up allocations, and HEIF business and

commercialisation supplement). Regions are defined as ITL1 (International Territorial Level 1). The regional weightings are based on two elements:

- a. A regional R&D investment weighting determined using the gross domestic expenditure on research and development (GERD²) values for each ITL1 region in 2019 (the most recently available data year) normalised by the number of HEIF recipients for each ITL1 region, and inverting this weighting.
- b. A regeneration income weighting based on the total regeneration programmes income in academic year 2021 to 2022 (the most recently available data year) totalled for HEIF recipients in each ITL1 region.
- 5. The final regional percentage weightings are determined by multiplying the regional regeneration and R&D investment weightings, applying these to existing HEIF allocations and scaling for available funding.
- 6. RIF allocations should be spent within the financial year 2023 to 2024. Funds must be used for knowledge exchange (activities must involve an external to the HEP partner), and specifically must be used for activities focussed particularly on business engagement and that further economic growth and productivity, and these activities must be addressing local/regional priorities. RIF may be used for expenditure from the date of the funding announcement by the Secretary of State for Science, Innovation and Technology on 3 October 2023.
- 7. Funds can be used for revenue and capital expenditure. Capital use may include the purchase of equipment expressly for the purpose of knowledge exchange activities with external partners in line with fund priorities. For the avoidance of doubt, the use of this funding for capital expenditure relates to the RIF pilot funding only. Capital expenditure remains ineligible for HEIF allocations and related supplements including the business and commercialisation supplement.
- 8. HEPs have discretion to focus RIF on the local/regional spatial footprint that is sensible for them in their primary geographic location. For example: related to their local partners, which may be local, combined or mayoral combined authorities, but also local R&D including business partners. We recognise that HEPs are likely to need to involve partners from outside of their chosen footprint. For example, specialist investors or research partners to enable activity, but the primary focus should be local/regional (to the HEP) partners, priorities and impacts.
- 9. RIF allocations will be monitored via the existing HEIF Annual Monitoring Statement (AMS) process. HEPs will be asked to report on use of RIF allocations against the same infrastructure and expenditure categories as for HEIF (with RIF use being recorded

separately to that of HEIF). We may also ask HEPs for examples of activity supported by RIF, to provide case studies of innovative approaches being supported through the funding, including for development of future policy.

10. The RIF allocations for each HEP in receipt of these funds are given in Annex B and have been added to Table 5 of workbook <u>Grant allocation data 2023 to 2024</u>. The funding will be paid in November 2023.
