Award of call-off Contract for UCSW System Mod Support under framework Agreement dated 08 January 2024 made between Houlder Limited (the “Supplier”) and United Kingdom Research and Innovation (“UKRI”) (the “Agreement”)

As you know, the Agreement anticipates that UKRI may from time to time agree call-off contracts with you.

For the purposes of the Contract, UKRI and the Supplier agree as follows:

- 2 Contract Expiry Date: 01 October 2024.
- 3 UKRI may extend this Agreement for a period of up to 12 months by giving not less than 1 month notice in writing to the Supplier prior to the Contract Expiry Date. The terms and conditions of this Agreement shall apply throughout any such extended period.

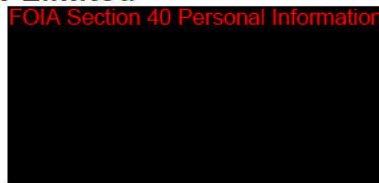

During the season the ship has suffered significant pitting to certain SS components such as the filter housing and SS bulkhead pipe penetration. There has also been an issue with broken GF plastic pipe valves cracking which creates a flood risk to the compartment. Pipework needs to be reviewed with a view to changing to something more robust such as rubber lined SS as well as the valves changing to something like Saunders rubber lined valves.
